OVERVIEW

This memorandum provides a formal, sworn record of criminal allegations and evidentiary communications delivered to the Huntington Beach Police Department (HBPD) and related law enforcement agencies between February and June 2025. These reports concern a pattern of racketeering activity, wire and mail fraud, forged contracts, senior abuse, retaliatory eviction, and obstruction of justice involving multiple actors connected to Berkshire Hathaway HomeServices franchise operations.

BACKGROUND

Michael Gasio is a retired educator, former school administrator, and code professional. He was a long-term tenant under a signed lease agreement at a property located in Huntington Beach, California. Over the course of three years, the tenancy was extended through documented and signed agreements, including a \$5,000/month lease renewal arranged by Anna Ly.

In early 2024, the property owner, Dr. Phat Tran, initiated a campaign of retaliatory and unlawful conduct. After accepting lease renewal payments and acknowledging receipt of funds through his agent, Hanson Le, Tran attempted to invalidate the lease through a fraudulent contract to raise rent and forcibly remove the tenant. Despite acknowledging in writing that he wished to retain the tenant and confirming payment, Tran and his affiliates orchestrated an unlawful eviction through Silverstein Evictions.

The court was never informed that (a) the original lease renewal was valid and notarized, (b) the payment was received by the agent, and (c) the eviction was based on a counterfeit contract and false financial statements. These facts were suppressed during trial.

NAMED INDIVIDUALS UNDER INVESTIGATION

- **1. Dr. Phat K. Tran** Property owner. Accepted certified funds for lease renewal, later concealed payment. Involved in perjury, forgery, wire fraud, and elder abuse. Used threats and intimidation, including third-party coercion, to extort private payments.
- **2. Hanson Le** Agent of record under Berkshire Hathaway. Accepted and concealed check. Later resigned via text and refused to return funds. Invoked the Fifth Amendment when questioned by HBPD. Participated in altering lease structure under false pretenses.
- **3. Steven D. Silverstein, Esq.** Filed unlawful eviction using forged documents and knowingly false declarations.

- invade assertions in court that contradict dated financial evidence. Falled to perform proper due diligence or investigate agent authority. Alleged to have participated in wire fraud, mail fraud, and obstruction of justice.
- **4. Anna Ly** Presented original lease renewal offer. Later disclaimed authorship of lease. Participated in administrative concealment.
- **5. Martha Mosier** President, Berkshire Hathaway HomeServices California. Was directly notified by certified mail of agent misconduct and franchise-level liability. Responded by denying corporate responsibility despite clear franchise agency involvement.
- **6. Richard Rosiak, Esq.** Accepted payment to represent Gasio, then abandoned representation prior to trial without filing evidence or notifying the court. Failed to respond to requests to inform liability insurance carrier.
- **7. LY Construction** Unknown party tied to renewal documents and suspected of ghost-managing the property. Listed on contract associated with rent scheme.
