Strategic Order for Prosecution

- 1. Lead counts: 18 U.S.C. §1343 (Wire Fraud) and Penal Code §518 (Extortion) for initial arrest and search authority.
- 2. Apply RICO overlay for asset seizure and agency liability.
- 3. Enhance sentencing under Civ. Code §3345 for elder victim status.
- 4. Offer plea to single state felony with restitution and testimony against co-defendants.
- 5. Retain civil claims for treble damages and attorney-fee recovery.
