Your Honor,

I respectfully request that the enclosed materials and online evidence portal be reviewed and referred to the proper investigative authorities. I make no request for advice from the court and do not seek to influence any ongoing or future proceedings. As a retired public servant, my goal is simply to ensure that this matter receives appropriate legal examination.

The facts concern a landlord who issued a **written receipt for rent payment** under a signed contract with Berkshire Hathaway, then demanded additional payment to a **private account** twenty-one days later. Further, the landlord served a **three-day notice to vacate** on only one of three lawful residents without proper notice to the others, who had occupied the home continuously since 2022.

These acts appear to constitute California Penal Code §470 (forgery), §484 (theft by false pretenses), and §532 (obtaining money by deceit), as well as Civil Code §1946.1 violations regarding improper service of notice to tenants. The supporting documents, correspondence, and certified mail records are preserved within the portal.

I have refrained from submitting this during the court's active phase to avoid interference. Now that the review period has closed, I respectfully ask that your office forward the provided materials to the appropriate agencies for review under standard investigative procedure.
