Interpretation

Each UPS record includes sender name (Michael Gasio), origin address (19227 Freshwater Cr., Huntington Beach CA 92648), and identical shipment timing, proving coordinated same-day submissions. The combined receipts total over \$180 in verified expenditure, all logged in the self-representation binder under "Printing and Mailings." Each tracking code matches the UPS logs printed 10/18 2025 (see *ups14.pdf* pp. 1–14).
