# **Summary**

This record preserves the email titled "NOTICE OF INTENT TO EXCHANGE CHECKS", sent by Michael A. Gasio on April 17, 2025, to Phat Tran, attorney Steven D. Silverstein, Shawn Randell (HBPD), and copied to the U.S. Department of Justice — Criminal Fraud Division. The message notified all parties that the landlord had not returned a previously tendered electronic deposit and that, in accordance with contract law, a second check would be required to make the tenant whole.

The letter was issued after the landlord failed to return an electronic rent deposit previously sent via Wells Fargo on June 28, 2024. The funds were held, never returned by the post office or the bank, and no receipt was issued. This notice establishes that the tenant took lawful steps to resolve the missing payment by offering to exchange or reissue the instrument.

By continuing to assert in court that "no payment was made" after receipt of this written notice, the opposing party introduced false evidence and misrepresented the financial record. This qualifies as *fraud on the court* under **California Code of Civil Procedure §128.7** and may also constitute *mail fraud* and *bank instrument concealment* under **18 U.S.C. §§1341–1344**.
