## T77 – Attempted Assault / Extortion by Vehicle

### **Summary**

This exhibit captures a violent and coercive encounter at the Huntington Beach rental property, involving an unidentified male driver of a **silver pickup truck** who entered the private driveway and **accelerated toward tenant Michael Gasio** while demanding immediate cash payment to a private bank account. The incident occurred shortly after rent was lawfully paid to agent **Hanson Le** on May 30, 2024. The suspect claimed to be "the owner" and threatened violence when asked to identify himself.

### **Timeline of Events**

- May 30, 2024: Rent payment submitted electronically to Berkshire Hathaway representative.
- July 7, 2024 (approx. 7:30 AM): Silver pickup truck parks in red zone in front of residence.
- Driver opens garage door of neighboring property, starts engine, and drives up onto the lawn and sidewalk toward the tenant.
- Driver exits vehicle, confronts tenant, and demands cash payment within 3 days or eviction.
- Tenant, age 72 and on a heart monitor, immediately documents the event and emails the **Huntington Beach Police Department** and other parties, including attorney **Steven D. Silverstein** and realtor **Hanson Le**.
