# **Summary**

This record outlines observed conduct, communications, and procedural inconsistencies by the agent identified in evidence file A1 (T89). It consolidates findings from verified emails, text records, and court disclosures spanning **July 2024** – **January 2025**.

#### **Conduct Overview**

- Initiated and transmitted lease documents under questionable authority, lacking verified brokerage oversight.
- Issued move-out and closing correspondence during active lease term, indicating premature termination intent.
- Ignored repeated written notices from tenant disputing authenticity of the lease and payment trail.
- Failed to issue required **90-day rent-increase notice** per *California Civil Code §1947.10*.
- Communicated with multiple third parties regarding contract terms without authorization or consent from the tenant of record.
- Misrepresented pet authorization and lease continuity during the second and third contract years.

# **Findings**

- Pattern of unauthorized communication with the property owner, resulting in conflicting lease documents.
- Failure to respond to multiple discovery requests or produce required records in compliance with court instructions.
- Conduct may constitute violations of *Cal. Bus. & Prof. Code §10176(a)* (misrepresentation) and *§10177(g)* (dishonest dealing).
- Subject demonstrated disregard for agency boundaries and continued activity after formal disputes were initiated.
